#### **BYLAWS**

# LEAGUE OF WOMEN VOTERS OF DELAWARE BYLAWS as amended by 2011 Convention

# ARTICLE I

NAME

**SECTION 1. NAME**. The name of this corporation shall be the League of Women Voters of Delaware. This state League is an integral part of the League of Women Voters of the United States.

# ARTICLE II PURPOSES AND POLICY

**SECTION 1. PURPOSES**. The purposes of the League of Women Voters of Delaware are to promote political responsibility through informed and active participation in government and to act on selected government issues.

**SECTION 2. POLICY.** The League may take action on state governmental measures and policies in the public interest in conformity with the principles and positions of the League of Women Voters of the United States, and of the League of Women Voters of Delaware. It shall not support or oppose any political party or candidate.

# ARTICLE III MEMBERSHIP

**SECTION 1. ELIGIBILITY**. Any person who subscribes to the purposes and policy of the League shall be eligible for membership.

#### **SECTION 2. TYPES OF MEMBERSHIP**

Sec. 2. Types of Membership

a. Voting Members. Citizens at least 18 years of age who join the League shall be voting members of local Leagues, state Leagues and of the LWVUS; (1) individuals who live within an area of a local League may join that League or any other local League; (2) those who reside outside the area of any local League may join a local League or shall be state members-at-large; (3) those who have been members of the League for 50 years or more shall be honorary life members excused from the payment of dues.

b) Associate members shall be all other members who are enrolled in recognized local Leagues.

# ARTICLE IV OFFICERS

**SECTION 1. ENUMERATION AND ELECTION OF OFFICES.** The officers of the League of Women Voters of Delaware shall be a PRESIDENT, a FIRST VICE-PRESIDENT, a SECOND VICE-PRESIDENT, a SECRETARY, and a TREASURER. The term [president] shall also mean one of two elected co-presidents. They shall be elected by the Convention and shall hold office for a term of two years, or until their successors have been elected and qualified.

**SECTION 2. THE PRESIDENT**. The President shall preside at all meetings of the organization and of the Board of Directors unless she/he shall designate some one to preside in her/his stead. The President may, in the absence or disability of the Treasurer, sign or endorse checks, drafts and notes. The President shall be, ex officio, a member of all committees except the Nominating Committee. The President shall have such usual powers of supervision and management as may pertain to the office of President and perform such other duties as may be designated by the Board.

**SECTION 3. THE VICE-PRESIDENTS.** The two Vice-Presidents, in the order of their rank, shall in the event of absence, resignation, disability, or death of the President, possess all the powers and perform all the duties of that office. In the event that neither Vice-President is able to serve in this capacity, the Board of Directors shall elect one of its members to fill the vacancy. Any person succeeding to the Presidency to fill a vacancy shall hold office for the remainder of the term for which her/his predecessor was elected. The Vice-Presidents shall perform such other duties as the President and Board may designate.

**SECTION 4. THE SECRETARY**. The Secretary shall keep minutes of all Conventions of the League, and of all meetings of the Board of Directors. The Secretary shall send a copy of the convention minutes to the state President and the League office within sixty days of the Convention. The Secretary shall notify all Officers and Directors of their elections. The Secretary shall sign, with the President, all contracts and other instruments when so authorized by the Board, and shall perform such other functions as may be incident to her/his office.

**SECTION 5. THE TREASURER**. The Treasurer, or her/his duly appointed assistant, shall collect and receive all moneys due. The Treasurer shall be custodian of these moneys, shall deposit them in a bank or banks designated by the Board of Directors and shall disburse the same only upon order of the Board of Directors. The Treasurer shall present periodic statements to the Board at its regular meetings, and an annual report to the Convention. The books of the Treasurer shall be audited biannually at the end of each term.

### ARTICLE V BOARD OF DIRECTORS

**SECTION 1. NUMBER, MANNER OF SELECTION AND TERM OF OFFICE**. The Board of Directors shall consist of the Officers of the League, six elected Directors, and not more than six appointed Directors. The Directors shall be elected at each convention and shall serve for a term of two years or until their successors have been elected and qualified. The elected members shall appoint such additional Directors, not exceeding a total of six any time, as they deem necessary to carry on the work of the League. The term of office of the appointed Directors shall expire at the conclusion of the Convention following their appointment.

**SECTION 2. QUALIFICATIONS.** No person shall be elected or appointed or shall continue to serve as an officer or director of this corporation unless she/he is a voting member enrolled in a local League of Women Voters in the State of Delaware. Three consecutive absences from State Board meetings without notification to the president (or other convener) shall be deemed a resignation from the Board.

**SECTION 3. VACANCIES.** Any vacancy other than in the office of the President may be filled, until the next Convention, by a majority vote of the remaining members of the Board.

**SECTION 4. POWERS AND DUTIES**. The Board of Directors shall have full charge of the property and business of the corporation, with full power and authority to manage and conduct the same, subject to the instructions of the Convention. The Board shall plan and direct the work necessary to carry out the program on state governmental matters as adopted by the Convention. It shall accept responsibility delegated to it by the Board of Directors of the League of Women Voters of the United States for the organization and development of local Leagues, for the carrying out of program and for promotion in the local Leagues of finance programs requisite to further the work of the local Leagues as a whole. The Board shall create and designate such special committees as it may deem necessary.

**SECTION 5. REGULAR MEETINGS.** There shall be at least five regular meetings of the Board of Directors annually. The President shall notify each member of the Board of Directors of all regular meetings by e-mail or by mailing to each member's last known post office address, at least one week before any such meeting, notice thereof, giving the time and place of the meeting. No action taken at any regular Board meeting attended by three-fourths of the members of the Board shall be invalidated because of the failure of any member or members of the Board to receive any notice properly sent, or because of any irregularity in any notice actually received.

**SECTION 6. SPECIAL MEETINGS.** The President may call special meetings of the Board of Directors and shall call a special meeting upon the request in writing or by e-mail of three members of the Board. Members of the Board shall be notified of the time and place of special meetings by telegram, e-mail, letter or telephone at least two days prior to such meeting. During a Convention the President may, or upon the request of three members of the Board, shall call a special meeting of the Board by handing the members of the Board a written notice of the time and place of such meeting.

**SECTION 7. QUORUM.** A majority of the members of the Board of Directors shall constitute a quorum.

**SECTION 8. LOCAL LEAGUE PRESIDENTS.** Local League presidents or their designees shall have a vote at State Board meetings.

#### **SECTION 9. ELECTRONIC VOTING**

To facilitate prompt decision making between Board meetings when delay seems inadvisable, an electronic vote of Board members may be taken using the following procedure:

- a. the President deems a prompt decision is necessary;
- b. sufficient background information is supplied to Board members to enable them to cast an informed vote;
- c. Board members must send their electronic yea or nay vote to all Board members;
- d. a majority of the Board must vote affirmatively for the proposed action to be approved
- e. Board members who do not have access to electronic mail must be polled by telephone or in person with background information having been supplied,

f. the vote, either yea or nay, shall be re-affirmed for recording purposes in the minutes, at the next Board meeting.

#### SECTION10. BOARD OF DIRECTORS.

Board meetings may also be conducted using electronic means of communication (e.g. Skype, conference call, etc.) as long as all Board members have been notified in advance, arrangements for participation have been made to be inclusive, and a quorum is expected to participate.

# ARTICLE VI RECOGNITION OF LOCAL AND PROVISIONAL LEAGUES

**SECTION 1. STATUS**. Local and Provisional Leagues shall be established and operated as divisions or chapters of the state League in accordance with the terms hereinafter set forth. Such status as divisions or chapters shall not, however, derogate from the primary responsibility of the local Leagues to the League of Women Voters of the United States.

#### **SECTION 2. LOCAL LEAGUES.**

- a) Local Leagues are those Leagues which have been so recognized by the League of Women Voters of the United States.
- b) The Board of Directors shall recommend to the National Board that the National Board recognize as a local League any group of members of the League of Women Voters of the United States in any community within the state provided the group meets recognition standards for local Leagues as adopted by the National Convention.
- c) In the event of recurring failure of a local League to meet recognition standards, the Board of Directors shall recommend to the National Board that the National Board withdraw recognition from the local League. All funds held by a local League from which recognition has been withdrawn shall be paid to the League of Women Voters of Delaware.

#### **SECTION 3. PROVISIONAL LEAGUES**

- a) Provisional Leagues are those Leagues which have been so recognized by the League of Women Voters of Delaware.
- b) The Board of Directors has a responsibility for the establishment of new Leagues. For this purpose the Board may organize a group of citizens in a community in which no local League exists and shall recognize the group as a provisional League when it meets the recognition standards adopted by the National Convention.
- c) The Board of Directors shall withdraw recognition from a provisional League for recurring failure to meet the standards for recognizing a provisional League or for failure to progress toward recognition as a local League. All funds held by a provisional League from which recognition has been withdrawn shall be paid to the League of Women Voters of Delaware.

# ARTICLE VII NOMINATIONS AND ELECTIONS

**SECTION 1. NOMINATING COMMITTEE.** The Nominating Committee shall consist of five members, two of whom shall be members of the Board of Directors. The chairperson and two members, who shall not be members of the Board of Directors, shall be elected by the Convention. Nominations for these offices shall be made by the current Nominating Committee. The other members of the Committee shall be appointed by the Board of Directors soon after the Convention. Any vacancy occurring in the Nominating Committee by reason of death, resignation or disqualification shall be filled by the Board of Directors. The President of the League of Women Voters of Delaware shall send the name and address of the chairperson of the Nominating Committee to the president of each recognized local League.

**SECTION 2. SUGGESTIONS FOR NOMINATIONS**. The chairperson of the Nominating Committee shall request, through the president of each local League, suggestions for nominations for offices to be filled. Suggestions for nominations by local Leagues shall be sent by the president or secretary of such local League to the chairperson of the Nominating Committee at least three months before the Convention. Any member may send suggestions to the chairperson of the Nominating Committee.

### SECTION 3. REPORT OF NOMINATING COMMITTEE AND NOMINATIONS FROM THE

**FLOOR**. The report of the Nominating Committee of its nominations for officers, directors, and the chairpersons and two members of the succeeding Nominating Committee shall be sent to the local Leagues one month before the date of the Convention. The report of the Nominating Committee shall be presented to the Convention at its first meeting. Immediately following the presentation of this report, nominations may be made from the floor, provided that the consent of the nominee shall have been secured.

**SECTION 4. ELECTION**. The election shall be in the charge of an Election Committee appointed by the president at the first meeting of the Convention. The election shall be by ballot, except that when there is but one nominee for each office, it shall be in order to move that the Secretary cast the ballot for every nominee. A majority vote shall constitute an election.

# ARTICLE VIII FINANCIAL ADMINISTRATION

**SECTION 1. FISCAL YEAR.** The fiscal year of the League of Women Voters of Delaware shall be July 1 to June 30.

#### Amend Article VIII Financial Administration

**SECTION 2. BUDGET**. The Board shall submit to the Convention for adoption a budget for the ensuing two years. A copy of the budget shall be sent to each local League President within one week following the regularly scheduled March State Board Meeting in that year.

**SECTION 3. BUDGET COMMITTEE.** The Budget shall be prepared by a committee which shall be appointed for that purpose at least four months in advance of the Convention. The Treasurer shall be an ex-officio member of the Budget Committee but shall not be eligible to serve as chairman.

SECTION 4. DISTRIBUTION OF FUNDS ON DISSOLUTION. In the event of a dissolution for any

cause of the League of Women Voters of Delaware, all moneys and securities which may be at the time owned by or under the absolute control of the League of Women Voters of Delaware shall be paid to the League of Women Voters of the United Sates after the Board of Directors has paid or made provision for the payment of all liabilities of the League of Women Voters of Delaware. All other property of whatsoever nature, whether real, personal, or mixed, which may at the time be owned by or under the control of the League of Women Voters of Delaware shall be disposed of by any officer or employee of the corporation, for such public charitable or educational uses and purposes as may be designated by the Board of Directors of the League of Women Voters of Delaware.

**SECTION 5. FINANCIAL SUPPORT**. Each local League shall make an annual per member payment for each of the next two years to the League of Women Voters of Delaware in an amount to be determined by a three-fifths vote of those present and voting at the convention.

When two or more members reside at the same address in a common household, the payment determined by the convention shall be made for the first member; a payment equal to one half the per member payment shall be paid for each other member. A local League shall be excused from making a per member payment for honorary life members.

# ARTICLE IX PROGRAM

**SECTION 1. PRINCIPLES.** The governmental principles adopted by the National Convention and supported by the League as a whole, constitute the authorization for the adoption of the Program.

**SECTION 2. PROGRAM**. The Program of the League of Women Voters of Delaware shall consist of:

- a) Action to implement the principles, and
- b) Those governmental issues chosen for concerted study and action.

#### **SECTION 3. CONVENTION ACTION.**

The Convention shall act upon the Program using the following procedures:

- a) Local League Boards shall make recommendations for a Program to the Board of Directors before the regularly scheduled March State Board Meeting in the year in which the Convention is held.
- b) The Board of Directors shall consider the recommendations and shall formulate a proposed Program which shall be submitted to the local League Boards following the March State Board Meeting and prior to each regularly scheduled local League Board meeting.
- c) Recommendations for changes submitted by local League Boards shall be considered by the Board of Directors at its regularly scheduled April meeting, and its final proposed Program shall be sent within one week to local League Boards.
- d) When revisions are made in recommended Program items, these items, may not be voted on by the Convention in the same session in which they are proposed.

- e) A majority vote shall be required for the adoption of the Program proposed by the Board of Directors.
- f) Any recommendations for the Program submitted to the Board of Directors at least two weeks before the Convention, but not proposed by the Board, may be adopted by the Convention provided that consideration is ordered by a majority vote, and in a later meeting the proposal receives a 3/5 vote.
- g) Program items may be recommended for cooperative study. Cooperative studies are those which may not be researched by all local Leagues. The Study committee(s) shall act as the resource committee for all Leagues within the State. All local Leagues shall participate in the consensus arising from a Cooperative study.

**SECTION 4. COUNCIL ACTION**. Emergent issues arising between biennial Conventions may be adopted for study at Council providing that the proposed study:

- a. has been approved by the Board;
- b. an affirmative vote of all local League Boards shall have been reported to the LWVDE President;
- c. notice of the proposed vote at Council shall have been given to local Leagues at least two weeks prior to Council.

**SECTION 5. ACTION.** Members may act in the name of the League of Women Voters of Delaware only when authorized to do so by the Board of Directors of the League of Women Voters of Delaware.

**SECTION 5. LOCAL LEAGUE ACTION.** Local Leagues may take action on state governmental matters only when authorized to do so by the Board of Directors of the League of Women Voters of Delaware. Local Leagues may act only in conformity with, or not contrary to, the position taken by the League of Women Voters of Delaware, and/or the League of Women Voters of the United States.

# ARTICLE X CONVENTION

#### Amend Article X Call to Convention

**SECTION 1. PLACE, DATE, AND CALL**. A Convention of the League of Women Voters of Delaware shall be held in odd numbered years between May 1 and June 15 inclusive, at a time and place to be determined by the Board of Directors. The President shall send a first call for the Convention to the presidents of the local Leagues in January of the year of the Convention. Thereafter, the Board of Directors may advance or postpone the opening date of the Convention not more than two weeks. A final call for the Convention shall be sent to the presidents of the local Leagues at least thirty days before the Convention.

**SECTION 2. COMPOSITION**. The Convention shall consist of the delegates chosen by the members through the local Leagues in the number provided for in Section 4 of this Article, and the members of the Board of Directors of the League of Women Voters of Delaware.

**SECTION 3. QUALIFICATION OF DELEGATES AND VOTING**. Each delegate shall be a voting member enrolled in a recognized local League in the state of Delaware. Each delegate shall be entitled to one vote only at the Convention even though the delegate may be attending in two or more capacities. One transfer of credentials per delegate is permitted. The total number of credentials transfers per delegation shall

not exceed 10% (rounded to the nearest whole number) or one transfer, whichever is greater, of each local League delegation. Absentee or proxy voting shall not be permitted. The Convention shall be the sole judge of whether a delegate is qualified to vote.

**SECTION 4. REPRESENTATION**. The members of the League of Women Voters of the United States who are organized into recognized local Leagues in the state of Delaware shall be entitled to representation as follows.

- a) Each local League shall have four delegates, one of whom shall be the president or her/his designate.
- b) In addition, a League may have a delegate for the first 15 voting members and an additional delegate for each 15 voting members or major fraction (8 or more) thereof.

The record in the state office of the paid-up voting members of each local League in January shall determine the membership count for this purpose.

**SECTION 5. POWERS**. The Convention shall elect officers and directors as specified in Articles IV and V, shall adopt a budget and per member payment for the ensuing two years, shall consider and authorize for action a Program in accordance with Article IX, Section 3, transact such other business as may be presented.

**SECTION 6. QUORUM.** Fifteen voting delegates other than the Board of Directors shall constitute a quorum for the transaction of the business of the Convention, provided that there is representation from at least two local Leagues.

# ARTICLE XI COUNCIL

**SECTION 1, PLACE, DATE, AND CALL** A council of the League of Women Voters of Delaware shall be held in even numbered years between April 15, and May 31 at a time and place to be determined by the Board of Directors. The President shall issue invitations to the Council which shall consist of local League Presidents and Vice Presidents, or their designees, and the members of the Board of Directors of the League of Women Voters of Delaware.

**SECTION 2, POWERS** The Council shall amend the budget if needed, give guidance to the Board on Program and methods of work, and hear and discuss local League concerns.

# ARTICLE XII NATIONAL CONVENTION AND COUNCIL

**SECTION 1. NATIONAL CONVENTION**. The Board of Directors, at a meeting before the date on which names of delegates must be sent to the national office, shall elect delegates to that Convention in the number allowed the League of Women Voters of Delaware under the provisions of the Bylaws of the League of Women Voters of the United States.

**SECTION 2. NATIONAL COUNCIL**. The Board of Directors, at its meeting preceding the meeting of the Council of the League of Women Voters of the United States, shall elect delegates to such Council in the

number allowed the League of Women Voters of Delaware under the provisions of the Bylaws of the League of Women Voter of the United States.

# ARTICLE XIII PARLIAMENTARY AUTHORITY

**SECTION 1. PARLIAMENTARY AUTHORITY**. The rules contained in Robert's Rules of Order Revised shall govern the corporation in all cases to which they are applicable and in which they are not inconsistent with these Bylaws.

# ARTICLE XIV AMENDMENTS

**SECTION 1. AMENDMENTS**. The Bylaws may be amended by a two-thirds vote at any Convention, using the following procedures:

- a) Proposals for changes shall be submitted by any local League Board or individual League members before the regularly scheduled March State Board meeting.
- b) All amendments proposed by local Boards together with any recommendations of the Board shall be sent to the presidents of the local Leagues within one week following the regularly scheduled April State Board meeting.
- c) The presidents of local Leagues shall notify the members of their respective Leagues of the proposed amendments. Failure of a local League president to give such notice or failure of any member to receive such notice shall not invalidate amendments to the Bylaws
